The Tuolumne County General Plan defines the counties growth plan for the next 25 years. The last time this document was updated was in 1996 and the document is in the process of being revised by our five district supervisors. The information for the Tuolumne County Plan has been developed and now is being formalized into a draft document. This draft document is expected to be completed in early August 2018 and will be available at www.tuolumnecounty.ca.gov website when complete. A forty-five (45) day review period will begin at the release of the draft for comments from the people of Tuolumne County. After the comment period, the document will be updated with the changes that are approved by our supervisors and the final new County General Plan will be released in the December time frame. Maintaining Neighborhood Value

Our Ridgewood neighborhood is one of the most esteemed in Tuolumne County, according to the various real estate agencies and agents in the area, and we have all made a significant investment in our homes. To keep our high rating, and high values of our homes, each homeowner should be diligent about maintaining their home and property.

As a reminder, below are a few small tasks, and CC&R regulations, that we can all do to keep the appearance of each home, and the neighborhood as a whole, at its best.

- Cars and other vehicles should not be parked in the driveway for extended periods of time (exceptions for overnight guests, of course).
- Motor homes, boats, other vehicles should not be parked long-term where they are visible by any neighbor or common road.
- Landscaping should be maintained for maximum curb appeal (including the elimination of weeds, especially yellow star thistle).
- Garbage cans should be stored so they are out of sight (to be taken out the night before pick-up and taken in by the end of pick-up day).
