Firewise News and Updates

Hello fellow neighbors and friends of Ridgewood. I decided to volunteer as the Firewise chair to continue the efforts of Dennis Hebert, Michael Moore and the other members of the Ridgewood 108 Firewise committee. Their accomplishment of our community becoming a recognized Firewise USA neighborhood has numerous tangible and intangible benefits which would not have been available to us without a Firewise representative. My first order of business was to renew our Ridgewood 108 Firewise certificate.

Important benefits include creating a framework for reducing the risk of wildfire and learning about wildfire risks and the simple things each of us as individuals can do to reduce them.

My goal is to continue the process to learn about wildfire risks in our community and to find resources to accomplish fire-safe actions. I hope to create community-building events and build citizen pride for our community. I will not be successful on my own, this takes participation by each and every one of us to do our part on our individual lots!

With that said...I want to thank the property owners who have already taken the initiative to remove dead or broken trees and branches from their property. As Charles mentioned the much needed rain has also brought an intense growth of vegetation on our properties which also needs our individual attention before it gets out of hand.

This includes massive amounts of star thistle visible as I walk and drive our community. A quick note, star thistle is an aggressive invader that can outcompete most other vegetation to form monocultures. One individual plant can disperse up to 150,000 seeds in a single season, and the wind dispersed seeds can travel long distance. Be aware that star thistle on your property is **guaranteed** to invade adjacent properties as well. Be kind to your neighbors and properly remove the star thistle! Be a good neighbor and recognize the importance for every individual property owner to do their part to maintain their property and remove hazardous vegetation so as to reduce the potential for fire and to promote the safety and welfare of our community.

Whether your property is a vacant lot or with a structure that you personally live in, rent or lease; I encourage you to take vegetation management of such property seriously for the safety and welfare of yourself and your surrounding neighbors.

State Law PRC 4291 has passed in Tuolumne County and is enforced by CALFIRE. It requires property owners to manage vegetation within One hundred feet of their own building(s), dwelling(s) and structure(s) to prevent fire from spreading to wildland vegetation or from the vegetation to the buildings, dwellings, or structures.

Here are a few highlights from PRC 4291 that I believe are important and situations that presently exist and apply to our community in Ridgewood:

8.14.030 Definitions:

H. "Fire Hazard" means any condition, arrangement, or act which increases the hazard or menace of fire to a greater degree than customarily recognized as normal by persons in the public service of preventing, suppressing or extinguishing fire.

N. "Reduced Fuel Zone"

Cut or mow grass down to a maximum height of 4 inches.

8.14.040

Legal Authority for the County Ordinance. The County has the legal authority to adopt the provisions contained in this Ordinance as specified below:

A. The California Health and Safety Code, Division 12, Parts 5-6 Sections 14875-14931, which provides that an accumulation of weeds, grasses, hazardous vegetation and other combustible material may be declared a public nuisance, and provides guidelines for enforcement and abatement by the County.

8.14.060 Duty to Remove and Abate Hazardous Vegetation.

A. It should be the duty of every owner and/or responsible person of any parcel to remove hazardous vegetation from driveways, roadways and road easements.

2. Ten (10) feet Reduced Fuel Zone from roadway edge.

Neighborhood Watch Information

Hello Neighbors,

This past year has brought many changes to Ridgewood, including saying goodbye to neighbors that have been a part of our community for many years, and the exciting presence of new faces! I would like to remind all residents of the posted 25 mph speed limit through our surface streets. We have families with strollers and young children, as well as friends who come from all over Tuolumne County to enjoy our walkable neighborhood. It is imperative that we continue to make pedestrians feel safe and welcome by adhering to the speed limit.



In addition to the speed limit, I would like to remind all neighbors of the hazards that can occur when animals are not properly leashed when on walks or when not safely contained within your property. There has been a significant increase in traffic on our surface streets due to the surrounding roadwork, and I have witnessed multiple near-misses between loose dogs and speeding cars. I know that a loss of an animal would be devastating to any of us as responsible pet owners. I have also been informed of instances of loose dogs that have approached pedestrians on our surface streets and encourage all to research the California Dog Bite Law as well as Tuolumne County Ordinance 6.04.400, which prohibits owners from allowing any animal to "run at large." "At large" animals can be impounded by Animal Control and there is a significant cost to retrieve them from impound.

If you are concerned about a specific street or issue, please contact me so we can discuss it further.

For all emergencies, always dial 911.

For non-emergencies, contact the Tuolumne County Sheriff's Office Dispatch at 209- 533-5815.

Ridgewood Propane News

Dear Ridgewood Neighbor,

One of the benefits with paid 2023 membership dues and living in Ridgewood is that we have a Propane Cooperative Program that annually negotiates on behalf of our 164 homes to identify the best supplier(s).

J.S. West has committed to this price effective January 1, 2022 through December 31, 2023, at which time competitive offerings will be requested for the coming year 2024.

To calculate the price per gallon, go to the following link:

Select the week your delivery will be made, find the Market Base Rate for TARGA-SF and add to your Supplier's Vender Fee; this is your estimated price per gallon. Note the TARGA-SF price may change a few cents on a daily basis so anticipate some fluctuations. California requires suppliers to charge a HazMat Fee but it can be embedded in the Delivery Fee. the Delivery Fee and HazMat Fee (not multiplied by gallons), for the full delivery price. Should you wish to confirm your delivered price contact the Supplier.

If you are not using our negotiated supplier, please consider changing over. Do not share information about this Propane Cooperative Program outside the Ridgewood Neighborhood Association area as this creates difficulties for our selected supplier(s) and could negatively affect our ability to negotiate in the future.

The rate is highly discounted due to benefits this program creates for both homeowners and suppliers: Homeowners receive best pricing, reduced frequency of changing supplier due to price, service quality and supply stability, a delivery driver knowledgeable of your property, rapid service if problems arise, fewer propane trucks traversing the area, and encourages supplier investments in fuel capacity.

Our Selected Supplier(s) benefit from greater volume of business, long-term customer loyalty and retention, stabilized revenue from homeowners in an area most likely to pay their bills on time, reduced operational cost related to shutdown/startup of service, and increased delivery efficiency (timing/consolidating trips). Propane Price is not the only factor to consider when selecting your supplier. For example, JS West has and continues to make significant investments in Rail Terminal and local storage to ensure supply for existing customers. Customer service and responsiveness also should be considered.

As a reminder, this is an exclusive arrangement that benefits Ridgewood residents and the supplier(s). Please do not share outside the community as this may affect our ability to maintain this value.

Architectural Review Information

A quick reminder to current and potential property owners, that within the Ridgewood CC&R's;

Section 3.03 Architectural Control: *No building, fence, wall, obstructions, screen nor structure of any kind shall be constructed, erected or maintained upon the Project (Ridgewood), nor shall any alteration or improvement of any kind be made thereto until the same has been approved in writing by the Architectural Control Committee*.

For projects requiring a building permit from Tuolumne County, the County will not issue a permit without a letter of review provided by the Ridgewood Architectural Control Committee. If you are considering a project, I encourage you to contact one of the Committee members early on, to answer any questions or concerns you may have.

For a complete list of Architectural requirements and limitations visit the Ridgewood website.

Please remember that the Committee is not here to micromanage what you do on your property. Our role is to oversee the requirements within the CC&R's to maintain and enhance the values of everyone's property in this wonderful place we live, Ridgewood.
